**Laramie Addition,** Lot 45, Block 7, Filing #3, AKA 681 Cascadilla St Jessica introduces her project. They are planning a functional renovation, not adding any square footage. They want to add a dormer. Exterior renovations include painting the siding, adding metal, and replacing the windows for energy efficiency.

Lori asks a question about a deck. Sue asks a question about metal and windows.
