1. Which of these Short-Term Rental options would you prefer in CB South?

The Short-Term Rental policy is our community would remain without change to the covenants but with enhanced regulations regarding to community and behavior crafted and adopted by the board: **217 (43.31%)**

Short-Term Rentals in out community are restricted by allowing only a certain percentage of residents to have a STR license: **18 (3.59%)**

Short-Term Rentals in our community are restricted by limiting the number of nights available to rent each property per year: **102 (20.36%)**

Short-Term Rentals in out community are restricted by allowing only a certain percentage of residents to have a STR license AND limiting the number of nights available to rent for those properties per year: **164 (32.73%)**
