- The 2024 season consists of 11 weeks. A weekly commitment of participation, with a minimum of 9 weeks, is requested.
- Vendor acknowledges that she/he has paid all fees and obtained all permits, including without limitation all health-related permits, which are required for her/his operation.
- Vendor will always adhere to the Gunnison County Public Health Orders, as designated for outside market business groups.
- Vendor shall be responsible for maintaining the area within and in proximity to her/his cart in a neat, clean and hazard free condition, and shall always provide a trash receptacle.
- No signs or placards shall be placed or erected by Vendor, other than on the tent, and such signs or placards shall comply with Gunnison County and Crested Butte South's requirements.
- Vendor hereby agrees to indemnify and save harmless Crested Butte South Property Owner's Association's Board members, employees, and agents against any and all claims, liability and costs, including reasonable attorney's fees, arising from or by reason of activities carried on pursuant to this permit.
- Vendor acknowledges and warrants that she/he has obtained and will maintain in effect during the time she/he conducts activities pursuant to this Permit, public liability Insurance in the amount and with terms reasonable approved by the Crested Butte South Property Owner's Association's Board of Directors.
